KNOW ALL MEN BY THESE PRESENTS, that I, Mattie Norris

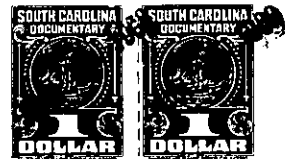
in consideration of Eight Hundred (\$800.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. W. Booker and Gladys Booker

All that lot of land in the county of Greenville, state of South Carolina, being a rear portion of lots Nos. 30 & 31 on plat of Map No. 2, Nickle-Town Heights recorded in plat book M page 5 of the RMC Office for Greenville County S. C. and being more particularly described as follows:

Beginning at an iron pin on the southerly side of Hall Street, which iron pin is 69.3 feet southwest from the northeast corner of River Street; thence with a new line across lots Nos. 30 & 31 S. 34-0 E. approximately 80 feet to an iron pin in line of Lot No. 32; thence with the line of said lot N. 56-00 E. 52 feet more or less to the rear joint corner of Lots Nos. 19 & 31; thence with the line of said lot 19, N. 34-0 W. 66 feet to an iron pin on the southerly side of Hall Street; thence with the southerly side of said street S. 66-30 W. 52.8 feet to the beginning corner.

This is a portion of the same lots conveyed to John & Mattie Norris by Timothy Lomax by deed recorded in deed vol. 476 page 496 of the RMC Office for Greenville County, S. C. John Norris subsequently died leaving his interest in the property to the grantor herein as will appear by reference to his will on file in the office of the Probate Court for Greenville County, S. C.
