ALL that certain piece, parcel or lot of land in the northern side of Holly Road and being known and designated as Lot #18 on a Plat of Edwards Forest Heights, said Plat being recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book 000, at Page 87, and having according to said plat the following metes and bounds, to-wit:

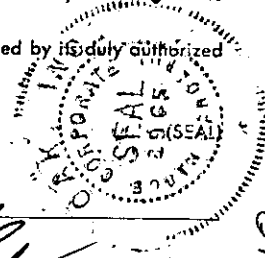
