All of that certain piece, parcel or lot of land in Butler Township, County of Greenville, State of South Carolina, and being a portion of Tract No. 8 of a subdivision of the John L. Green and Annie L. Green Estates according to a survey and plat by W. J. Riddle, Surveyor, dated January, 1943, and recorded in the R. M. C. Office for Greenville County in Plat Book "N" at page 153, and being a portion of that property of that property designated as Property of A. L. Tinsley on plat prepared by Webb Surveying and Mapping Co., June 2, 1964; and the property herein conveyed having the following metes and bounds:

BEGINNING at an iron pin on County Road at the joint front corner of property now or formerly of Burnside and running thence with the line of said property, S. 26-00 E. 741 feet to iron pin on line of property of T.
