in consideration of Six Thousand and no/100 (\$6,000.00) Dollars and assumption of mortgage as set forth below, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James W. Jones and Wynona R. Jones, their heirs and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the easterly side of Parkdale Drive, near the City of Greenville, S. C., being known and designated as Lot No. 59 on plat of Parkdale as recorded in the RMC Office for Greenville County, S. C., in Plat Book RR, page 55 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Parkdale Drive, said pin being the joint front corner of Lots 59 and 60 and running thence with the common line of said lots N 86-38 E 160 feet to an iron pin, the joint rear corner of Lots 59 and 60; thence N 3-22 W 134.6 feet to an iron pin on the southerly side of Parkdale Drive; thence with the southerly side of Parkdale Drive S 74-31 W 138.7 feet to an iron pin; thence on a curve, the chord of which is S 35-34 W 39 feet to an iron pin; thence S 3-22 E 75 feet to an iron pin, the point of beginning.
