KNOW ALL MEN BY THESE PRESENTS, that I, E. G. Whitmire, Jr

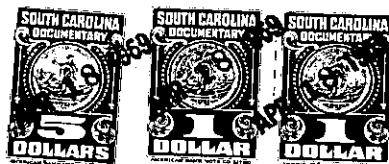
in consideration of Thirty-Five Hundred (\$3,500.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto U. L. West and Hazel W. West their Heirs and Assigns forever:

All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Austin Township, near Simpsonville, S. C., known as Rollingwood subdivision, and being designated as Lot No. 30, on a plat prepared by C. O. Riddle, Surveyor in February 1963, and having, according to said plat the following courses and distances, to-wit:

BEGINNING at an iron pin in the Southern edge of Green Hill Drive, joint front corner with Lot no. 29 on said Drive, and running thence with the joint line of said Lot No. 29, S. 7-22 E. 459.8 feet to an iron pin, back joint corner with said Lot No. 29; thence S. 61-01 E. 119.9 feet to an iron pin; thence N. 78-03 E. 147.3 feet to an iron pin, back joint corner with Lot No. 32; thence with the joint line of said Lot 32 N. 3-44 E. 290 feet to an iron pin, joint corner with Lot No. 31; thence with the joint line of said Lot No. 31 N. 10-40 W. 249.8 feet to an iron pin in the Southern edge of Green Hill Drive, joint front corner with said Lot 31; thence along the Southern edge of Green Hill Drive S. 79-20 W. 235 feet to an iron pin; thence continuing with the Southern edge of Green Hill Drive S. 8-59 W. 50 feet to an iron pin, the point of beginning, and bounded by Green Hill Drive, Lot No. 29, Lots Nos. 32 & 31.
