All that certain piece, parcel, or lot of land situate, lying and being in the state of South Carolina, county of Greenville, Gantt Township, being known and designated as Lot No. 13 of a subdivision of the property of Lanco, Inc. as shown on plat prepared by R. K. Campbell and Webb Surveying & Mapping Co., October 1963 and recorded in the RMC Office for Greenville County in Plat Book RR at page 199, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Dunlap Drive, joint front corner of Lots 12 and 13 and running thence along the joint line of said lots, S. 66-25 E. 130 feet to an iron pin on the subdivision property line; thence along the subdivision property line, S. 23-35 W. 70 feet to an iron pin at the rear corner of Lot 14; thence along the line of that lot, N. 66-25 W. 130 feet to an iron pin on the eastern side of Dunlap Drive; thence along the eastern side of Dunlap Drive, N. 23-35 E. 70 feet to the beginning corner.
