That I, JAMES M. JOSEPH

in consideration of the sum of Three Thousand Nine Hundred (\$3,900.00) ----- in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JAMES T. SHALEULY, his heirs and assigns, forever:

ALL that certain piece, parcel of lot of land lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 24 of Hollywood Subdivision, according to a plat by Pickell & Pickell, made June 4, 1947, and recorded in the RMC Office for Greenville County, S. C. in Plat Book S, page 37, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Hollywood Circle, at the joint lot corner of Lots 25 and 24, which is some 167.7 feet along the plat lines from the Southwest intersection of Hollywood Circle and Spartanburg Street; thence with the said Hollywood Circle, S. 51-45 W. 50 feet to an iron pin; thence N. 28-15 W. 125 feet to an iron pin; thence N. 51-45 E. 50 feet to an iron pin; thence S. 28-15 E. 125 feet to the point of beginning.

This being the same property conveyed to the grantor by deed of Samuel M. Witcher and Willie Mae Witcher by deed dated February 28, 1969, recorded in the RMC Office for Greenville County, S. C. in Deed Book 863 at page 189.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

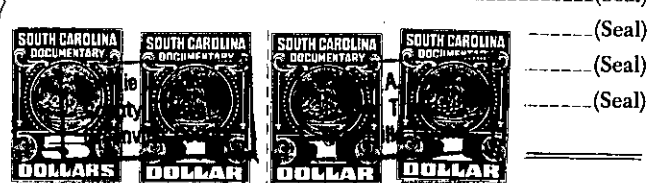
