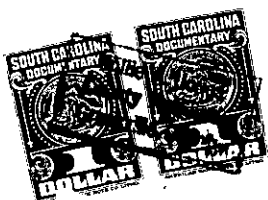
Henry C. Harding Builders, Inc., Its Successors and Assigns Forever:
