KNOW ALL MEN BY THESE PRESENTS, that We, James T. Crumpton and Lidie B. Crumpton

in consideration of One Dollar and correction of deed as shown below Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Charles Kellett, Sr., his heirs or assigns:

All that certain piece, parcel or tract of land, lying and being in Greenville County, Grove Township, State of South Carolina, located on the West side of the Fork Shoals Road, approximately fourteen miles from Greenville, South Carolina, adjoining other lands of Grantee, and having according to a survey and plat made by C. O. Riddle, Surveyor on April 2, 1958 the following metes and bounds, to-wit:

BEGINNING at a point in the center of the Fork Shoals Road, joint corner with property now owned by Grantee, and running thence N. 87-03 W. 198.4 feet to an iron pin; thence S. 6-40 W. 345.5 feet to an iron pin; thence N. 84-55 E. 224.7 feet to a point in the center of the Fork Shoals Road; thence along center of the Fork Shoals Road N. 39 E. 313.4 feet to the beginning corner, and being a portion of the same property conveyed to James T. Crumpton by deed from the United States of America recorded in Deed Book 254 at page 40 in the Greenville County R. M. C. Office and this conveyance carries the same rights of ingress and egress over a 20 foot strip on southern side as carried in a deed from James T. Crumpton to J. P. Kellett.

This deed is given to correct a deed dated July 28, 1965 and recorded in the Greenville County R. M. C. Office in Deed Book 837 at page 126. In that deed Lidie B. Crumpton did not sign and this is given so as to convey the entire interest of both parties to Charles Kellett, Sr.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)' heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
