KNOW ALL MEN BY THESE PRESENTS, that We, John T. Douglas, Sallie C. Huguenin and Nora Camille McDaniel Manning

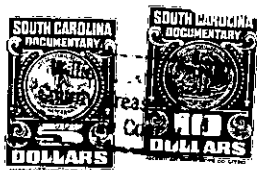
in consideration of SEVEN THOUSAND FIVE HUNDRED AND NO/100----- Dollars,

All that piece, parcel or lot of land situate, lying and being on Windmont Road in that certain subdivision known as "Barksdale" and being known as Lot No. 4 WINDMONT ROAD, according to a plat of Revision of Lots 3, 4, 5, 7, 9 and 10 of Barksdale, Greenville, S.
