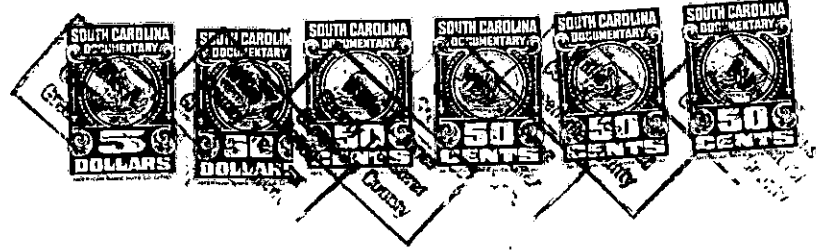
KNOW ALL MEN BY THESE PRESENTS, that I, Clarence A. Rochester, of Greenville County,

in consideration of Twenty-Eight Thousand, Three Hundred Fifty and No/100----- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto L. O. Boiter and Florine McKinney Boiter, their heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Dagenham Drive, near the City of Greenville, being shown as Lot #57 on plat of Section III, of Wade Hampton Gardens, recorded in Plat Book YY at Page 179, and described as follows:

BEGINNING at an iron pin on the western side of Dagenham Drive, at the corner of Lot 56, and running thence with the western side of said drive, S. 17-30 W. 110 feet to an iron pin, at the corner of Lot 58; thence with the line of said lot, N. 72-30 W. 160 feet to an iron pin in the line of Lot 47; thence with lines of Lots 47 and 48, N. 17-30 E. 110 feet to an iron pin, corner of Lot 56; thence with the line of said lot, S. 72-30 E. 160 feet to the point of beginning; being the same conveyed to me by John K. Temple, Jr. by deed dated October 7, 1965, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 783, at Page 481.
