the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Emmanuel Temple Pentecostal Church of Greenville, South Carolina, (Its Successors And Assigns, An Unincorporated Association)

ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, being a portion of Lot No. 92 on plat of Brookwood, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book BB, at Page 27, more fully described as follows: BEGINNING at iron pin on Gantt Drive, at corner of lot conveyed to Sallie Campbell; running thence along line of lands of Sallie Campbell South 3-15 West 100 feet; running thence along line of Lot 91 North 88 West 185.3 feet; thence North 3-15 East 100 feet to point on Gantt Drive; thence with Gantt Drive South 86-15 East 182.5 feet to the BEGINNING corner; being the identical property conveyed to Emmanuel Temple Pentecostal Assembly of the World by Emmanuel Temple, The Progressive Church of Jesus, by deed dated January 20, 1964, recorded in Volume 741 at page 202 in the office of the Register of Mesne Conveyance for Greenville County, South Carolina.

THE Purpose of this Deed is to remove the name "Progressive Church of Jesus" from the Church Property entered by mistake in a Deed noted in Deed Volume 757 at Page 336, Office of the R. M. C. for Greenville County, dated September 11, 1964. This action is pursuant to a Resolution from the Progressive Church of Jesus taken at its Annual Assembly at Florence, South Carolina on September 27, 1964, and dated December 29, 1964.

THE Grantee is now and has been pursuant to Resolutions of the local Church, being one Unit, has changed its name from Emmanuel Temple to Emmanuel Temple Pentecostal Church of Greenville, South Carolina.
