Malcolm Leopard, his heirs and assigns, forever:

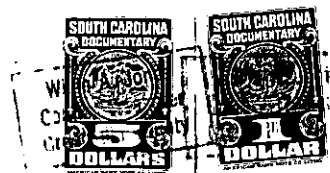
All my interest in and to:
