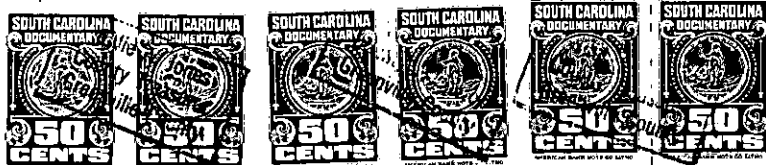
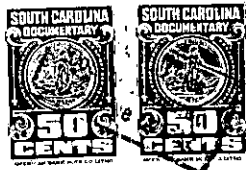
James E. Woodside and John W. Smith, their heirs and assigns forever:
