ALEENE PADEN:

All that certain piece, parcel or lot of land near the City of Greenville, County of Greenville, State of South Carolina, situate, lying and being on the Southern side of Crestfield Road, being known and designated as Tract No. 1 on a plat entitled "Property of Wister Louers, Jr. and Chester & Barker Louers and Willie L. Louers", dated August 22, 1969, prepared by C. O. Riddle and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern edge of Crestfield Road and running thence along said road, N. 85-22 E. 96.4 feet to an iron pin at the joint front corner of Tract No. 1 and Tract No. 2; thence leaving said road S. 13-13 E. 152.4 feet along the line of Tract No. 2 to an iron pin at the joint rear corner of Tract No. 1 and Tract No. 2; thence S. 86-24 W. 56.8 feet to an iron pin; thence S. 85-40 W. 16.6 feet to an iron pin; thence N. 21-33 W. 156.7 feet to an iron pin at the point of beginning and containing .29 acre, more or less.
