KNOW ALL MEN BY THESE PRESENTS, that I, VERGREE HILL,

in consideration of FIVE (\$5.00) DOLLARS (LOVE AND AFFECTION)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto MARGREE HENDERSON, her heirs and assigns, forever, a one-third (1/3) interest in and to:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near City of Greenville, in Brutontown north of and near old Camp (Rutherford) Road, being an unnumbered lot on plat made by G. A. Ellis, Sur., March 28, 1945, of the E. E. Watson property, and, according to said plat, in part, having the following metes and bounds, to-wit:

BEGINNING at a point on eastern side of a 15-foot roadway leading in a southerly direction to the old Camp (Rutherford) Road, which point is Thirty Three (33) feet southerly from corner of the Thomas Fuller lot, and running thence in an easterly direction along a line parallel with southern line of the Fuller lot and 33 feet therefrom at all points, a depth of One Hundred Twenty (120) feet to point; thence in a southeasterly direction in a line parallel with said 15-foot roadway; Fifty (50) feet to a point; thence in a southwesterly direction in a line parallel with first line above, One Hundred Twenty (120) feet to a point on eastern side of said roadway, which point is Fifty (50) feet southeasterly from point of beginning; thence N. 28-48 W. 50 feet along eastern side of said roadway to point of beginning.

This is a part of a tract of Six (6) acres, more or less, conveyed to E. E. Watson by deeds by J. P. Chappell, Farmer, Biggs and Graves, all recorded in R. M. C. Office and is the same property conveyed to Martha Henderson by E. E. Watson by Deed recorded in Book 488, Page 115, R. M. C. Office for Greenville County and is the same property conveyed to Vergree Hill by Martha Henderson by Deed recorded in Book 829, Page 211, R. M. C. Office for Greenville County.
