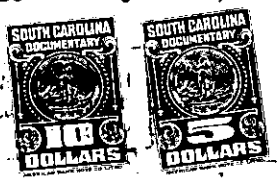

BEGINNING at a point on Whitman Drive at the joint front corner of Lots 54 and 55 and running thence N. 80-06 W., 210 feet to a point; thence turning and running N. 9-54 E., 100 feet to a point; thence turning and running S. 80-06 E., 210 feet to a point on Whitman Drive; thence turning and running S. 9-54 W., 100 feet to the point of beginning.
