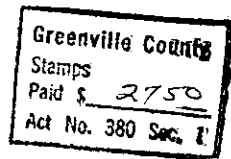

Beginning at an iron pin on the northeast side of Richwood Drive, the joint front corner of Lots Nos. 6 & 7; thence with the joint line of said lot N. 30-40 E. 143.7 feet to an iron pin; thence N. 53-15 W. 75.4 feet to an iron pin rear corner of Lot 5; thence with the line of lot 5 & 4, S. 30-40 W. 151.7 feet to an iron pin on the northeast side of Richwood Drive; thence with the northeast side of said street S. 59-20 E. 75 feet to the beginning corner.
