unto WOOTEN CORPORATION OF WILMINGTON, its successors and assigns;

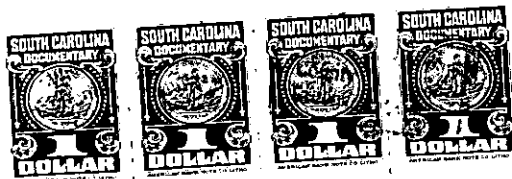

BEGINNING at an iron pin in the Southwestern intersection of Parkwood Avenue and Gallivan Avenue (formerly Boxwood Road) and running thence along Parkwood Avenue, S. 19-30 W. 212 feet to a point in the center of a branch; thence with the branch as the line, the traverse line being N. 66 W. 66.2 feet to a point in the center of the said branch; thence N. 19-30 E. 200 feet to an iron pin on Gallivan Avenue joint front corner Lots 10 and 11; thence along Gallivan Avenue S. 71-32 E. 66 feet to an iron pin, the point of beginning.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to Cameron-Brown Company, on which there is a balance due of \$ 7,307.01 ; said mortgage being recorded in Mortgages Volume 969, Page 101.
