THE STATE OF SOUTH CAROLINA,

KNOW ALL MEN BY THESE PRESENTS, That I,

O. C. Sublett of Pine Oaks Trailer Park, Wade Hampton Boulevard, Greenville, South Carolina

have constituted, made and appointed and by these presents do constitute, make and appoint my daughter, Sandra Gray Sublett Barrett, 4111 Beecliff Drive, Columbia, South Carolina, my

true and lawful Attorney for me and in my name and stead, and to use, to ask, demand, sue for, levy, recover and receive all such sum and sums of money, debts, rents, goods, wares, dues, accounts, and other demands whatsoever, which are or should be due, owing or payable to me or detained from

me in any manner or ways or means whatsoever:

1. To do business with banks, and to endorse all checks and drafts made payable to my order and collect the proceeds.
2. To sign in my name checks on all accounts standing in my name and to withdraw funds from said accounts.
3. To sign, execute, acknowledge and deliver in my name all assignments of securities.
4. To borrow money and to pledge securities for such loans if in the judgement of my attorney such action should be necessary.
5. To manage real property, to sell, convey and mortgage realty, and to take title to property in my name if she thinks proper, to execute, acknowledge and deliver deeds of real property, mortgages, releases, satisfactions and other instruments relating to realty which she considers necessary.
6. To represent me in all income tax matters before all officers of the Income Tax Bureau, to make and verify income tax returns, claims for refund, requests for extension of time, and consents in my name to execute petitions to represent me.

Giving and granting unto my said Attorney by these presents full and whole power, strength and authority, in and about the premises; she to have, use and take all lawful ways and means in my name for the recovery thereof; and upon the receipt of any such debts dues, or sums of money aforesaid, acquaintances or other sufficient discharges, for me and in my name to make, seal and deliver, and generally all and every other act and acts, thing and things, device and devices in law whatsoever needful and necessary to be done in and about the premises, for me and in my name to do, execute and perform, as fully, largely and amply, to all intents and purposes, as I might or could do, if I were personally present, or if the matter required more special authority than is herein given, and Attorneys, one or more, under fee for the purpose aforesaid, to make and constitute and again at pleasure to revoke, ratify, allowing and holding, for firm and effectual, all and whatsoever my said Attorney shall lawfully do in and about the premises, by virtue hereof.
