in the State aforesaid, in consideration of the ~~sum of~~ foregoing premises and of the sum of Three (\$3.00)-----

to us in hand paid at and before the sealing of these presents by

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Harry K. Clark, his Heirs and Assigns forever,

All our right, title, interest and inheritance in and to,

All that piece, parcel or tract of land lying, being and situate on the West side of the Adams Mill Road, near Five Forks, in County and State aforesaid, containing Four (4) acres, more or less, and having the following courses and distances, to-wit: Beginning at a point in said road and which point is N.87-35 E.18 feet from an Iron Pin, and running thence from said point S.87-35 W.623.3 feet to an Iron Pin, thence N.27-35 W.175 feet to an Iron Pin, thence N.74-10 E.794.7 feet to a point in said road (Iron Pin back on line at 21.25 feet), thence with said road S.10-00 W.351 feet to the beginning point. Bounded on the North by lands now or formerly owned by E. R. Gasque, on East by the Adams Mill Road, on South by a 3.13 acre tract as shown on the below mentioned plat, and on West by lands now or formerly owned by Donald D. Campbell.
