the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto

SHIRLEY F. HALL, her heirs and assigns forever:

ALL that certain piece, parcel or lot of land, lying in the State of South Carolina, County of Greenville, City of Greenville on the Southeastern side of Alpine Way, being shown and designated as Lot Number Thirty Six (36) on a plat of Property of Central Development Corporation, recorded in the RMC Office for Greenville County, South Carolina in Plat Book "BB" at pages 22 and 23, being further described as follows:

BEGINNING AT AN IRON PIN ON THE Southeastern side of Alpine Way, at the joint corner of Lots 36 and 37, and running thence along line of lot 37, S. 50-41 E., 175 feet to an iron pin on the line of Lot 41, thence along line of lots 41 and 42, N. 39-19 E., 75 feet to an iron pin on the corner of lot 35; thence, along line of lot 35, N. 50-41 W., 175 feet to an iron pin on the southeastern side of Alpine Way; thence along Alpine Way, S. 39-19 W., 75 feet to the point of beginning.

This conveyance is made subject to all protective covenants, rights-of-way and easements affecting the property appearing upon public records of Greenville County, South Carolina.

AS PART OF THE CONSIDERATION HEREOF, the Grantee agrees to assume and pay that certain mortgage given by the Grantors herein to C. Douglas Wilson & Company, recorded in the RMC Office for Greenville County, South Carolina in Mortgage Book 1132 at Page 261, on the 25th day of July, 1969, and having a present principal balance due in the amount of \$25,760.27.
