the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto HUGUENIN-DOUGLAS CO., its successors and assigns forever:

ALL that piece, parcel or lot of land, situate, lying and being on the North-western side of Quail Hill Drive, in Greenville County, Butler Township, South Carolina, being shown and designated as Lot No. 26 of QUAIL HILL ESTATES, as shown on a Plat of the Property of Thomas B. Huguenin and T. F. Huguenin, Jr., prepared by Campbell & Clarkson Surveyors, Inc., dated April 24, 1969, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book TTT, page 201, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwestern side of Quail Hill Drive at the joint frontcorner of Lots Nos. 25 and 26, and running thence along the line of Lot No. 25, N. 64-24 E., 250 feet to an iron pin; thence S. 25-36 W. 150 feet to an iron pin at the joint rear corner of Lots Nos. 26 and 27; thence with the line of Lot No. 27, S. 64-24 E., 250 feet to an iron pin on the Northwestern side of Quail Hill Drive; thence with Quail Hill Drive, N. 25-36 E., 150 feet to an iron pin, the point of beginning.

The above property is a portion of the same conveyed to the Grantors herein by deed of Sallie C. Huguenin dated March 21, 1969, and recorded in the RMC Office for Greenville County, S. C., in Deed Book 864, page 623, and is hereby conveyed subject to all rights of way, easements, agreements and restrictive covenants of record on the aforesaid plat, on recorded plat(s) and on the premises and is also subject to restrictive covenants applicable to Quail Hill Estates recorded in the RMC Office for Greenville County, S. C., in Deed Book 871, page 579.
