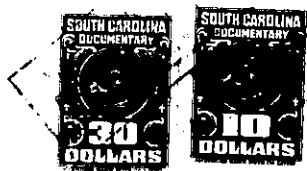

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 278, Section 6, Colonial Hills, as shown on plat thereof prepared by Piedmont Engineers & Architects, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book WWW at Pages 12 and 13, and having, according to said plat, the following metes and bounds, to-wit:
