ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville on Rollingwood Drive, being shown as Lot # 39 on plat of Edwards Forest Heights recorded in Plat Book 000 at Page 89, and being more fully described as follows:
