in consideration of ----Five and No/100----(\$5.00) Dollars, love and affection-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Martin Hilsman Dodenhoff, his heirs and assigns, an undivided one-half interest in and to,

ALL that piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Northerly side of SIRRINE Drive within the corporate limits of the City of Greenville, South Carolina, being shown and designated as all of Lot #5 and Westerly portions of Lot #6 according to Plat of L. A. Mills' property made by R. E. Dalton, C. E., March, 1925, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of SIRRINE Drive at joint front corner of Lots 4 and 5, which point is 341.9 feet Northeast of intersection of SIRRINE Drive with Augusta Road and running thence along the joint line of the said lots N. 25-28 W. 324.2 feet to an iron pin on line of property of H. T. Mills (or formerly); thence along the Mills line N. 65-10 E. 110 feet to an iron pin in the rear line of Lot #6; thence on a straight line through the west portion of Lot #6 S. 25-28 E. 323 feet to an iron pin on the Northerly side of SIRRINE Drive; thence along SIRRINE Drive S. 64-32 W. 110 feet to an iron pin at the point of beginning, and being the same property conveyed to Mary Frances Cooledge Dodenhoff by deed of The South Carolina National Bank of Charleston, dated July 29, 1936, recorded in Deed Volume 185 at Page 246 and by deed of Socarnat Bank Corporation to Mary Frances Dodenhoff, dated June 28, 1939, recorded in Deed Volume 212 at Page 213, R.M.C. Office, Greenville County, South Carolina.

The above described property is subject to existing easements, rights-of-way, reservations and restrictions.

By this deed, the full interest in the above described property has been conveyed to the grantee herein, the other one-half (1/2) interest having been conveyed to the grantee by the grantor's deed, dated October 15, 1970, recorded in Deed Volume 900 at Page 451, R.M.C. Office, Greenville County, South Carolina.
