the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto

VIRGINIA W. PEAK, HER HEIRS AND ASSIGNS FOREVER:

ALL that piece, parcel or lot of land in Austin Township, County of Greenville, State of South Carolina, known and designated as Lot No. 6 on a plat of property of Elles Williams by C. F. Webb, dated May 1970, bounded on the west by property of Tobie Allen (Tract 31 of G. C. Franklin Estate) on the south by property of Tobie Allen (Tract 11 of G. C. Franklin Estate), on the east by Lot No. 5 conveyed this date to James W. Williams and on the north by Vantross Lane, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at old iron pin on the southern side of Vantross Lane, joint corner with Allen property and running thence S. 62-35 E. 110.8 feet to an old iron pin; thence S. 64-10 E. 180.2 feet to an old iron pin; thence N. 55-30 E. 50 feet to an iron pin corner of Lot No. 5; thence along the line of Lot No. 5, N. 55-15 W. 271.9 feet to an iron pin on Vantross Lane; thence along Vantross Lane S. 55-30 W. 95 feet to the point of beginning.

This conveyance is made subject to the restrictive covenants of record and to any easements or rights of way affecting same.

This is a portion of the properties conveyed to the grantor by deed dated May 21, 1959, recorded in Deed Book 632 at page 229 and deed dated August 8, 1949, recorded in Deed Book 404 at page 473 of the RMC Office for Greenville County and is also shown as the western most portion of a plat of property of Elles Williams by R. B. Bruce, RLS, dated November 30, 1958, recorded in Plat Book SS at page 149 of the RMC Office for Greenville County.
