ALL that piece, parcel or lot of land in Austin Township, County of Greenville, State of South Carolina, known and designated as Lot No. 4 on a plat of property of Elles Williams by C. F. Webb, dated May 1970, be bounded on the west by Lot No. 5, on the south by property of Tobie Allen (Tract 11 of G. C. Franklin Estate), on the east by Lots No. 2, 3 and 4 and on the north by Vantross Lane, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southern side of Vantross Lane, corner Lot No. 5 and running thence S. 45-55 E. 259.4 feet to an iron pin; thence along the line of the Allen property, N. 55-30 E. 50 feet to an iron pin; thence N. 35-56 W. 254.4 feet to an iron pin on the southern side of Vantross Lane; thence along Vantross Lane, S. 55-30 W. 95 feet to an iron pin, the point of beginning.
