KNOW ALL MEN BY THESE PRESENTS, that OPEN BIBLE ASSEMBLY OF GOD (formerly known as the Wade Hampton Assembly Of God)

in consideration of One and No/100-----(\$1.00)----- Dollars

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto THE SOUTH CAROLINA DISTRICT COUNCIL OF THE ASSEMBLIES OF GOD, INC., its successors and assigns:

ALL that piece or parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina; having the following metes and bounds, to wit:

BEGINNING at an iron pin on Brushy Creek Road, corner of L. B. Plemmons lot, running North with Plemmons line, 234.5 feet to an iron pin on Boling line; thence East with Boling line, 109.6 feet to an iron pin on Boling line; thence with Hammonds property, S. 229 feet to an iron pin on Brushy Creek Road; thence with said road, N. 110 feet to the beginning corner.

The above property is the same conveyed to Wade Hampton Assembly of God by deed of James R. Dickerson and Mary B. Dickerson recorded in Deed Book , page

Wade Hampton Assembly of God on the date of conveyance to it of the above described property was an unincorporated Church. By unanimous vote of the members of said Church on November 20, 1966, the name of said Church was changed to Open Bible Assembly of God. The Open Bible Assembly of God, formerly known as Wade Hampton Assembly of God, has at all times been affiliated with the South Carolina District Council of the Assemblies of God, Inc. Article XII, subparagraph 1, of whose By-Laws and Constitution provided that all real estate shall be held in the corporate name of the District, i. e., South Carolina District Council of the Assemblies of God, Inc., and this conveyance is made to confirm title in the Grantee which was erroneously taken in the name of Wade Hampton Assembly of God.

This conveyance has been authorized and directed by the members of the congregation of the Open Bible Assembly of God (formerly Wade Hampton Assembly of God), at a duly called meeting conducted on January 31, 1971, at which a quorum was present, and at which John H. Sisk as Pastor, Mrs. Ann Sisk as Secretary, and Mitchell K. Burriss, Harold Howard and William Fielders, as Trustees, were authorized and directed to hold title to the above described property on behalf of said Church and to convey the same to the Grantee hereinabove named.
