in consideration of Thirteen Thousand and no/100 (\$13,000.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Helen L. Ulmer and Margaret E. Ulmer, their heirs and assigns forever

All those lots of land situate on the northerly side of La Vista Court in Greenville Township, City of Greenville, County of Greenville, State of South Carolina, being shown as lots 13 and 14 on a plat of the property of Ruth H. Lynch dated August 1962, prepared by Piedmont Engineering Service recorded in Plat Book XX at page 71 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of La Vista Court at the joint front corner of lot 12 and lot 13 and running thence with lot 12 N. 43-48 E. 160 feet to an iron pin at the joint rear corner of lot 12 and lot 13; thence with the rear line of lot 2 and lot 1 N. 46-12 W. 195 feet to an iron pin at the joint rear corner of lot 1 and lot 14; thence S. 45-40 W. 197.8 feet to an iron pin; thence S. 25-45 E. 180.8 feet to an iron pin on La Vista Court; thence with La Vista Court, the chords being N. 13-19 E. 32.3 feet, N. 42-53 E. 45 feet, N. 78-40 E. 35 feet, and S. 46-12 E. 30 feet to the point of beginning.

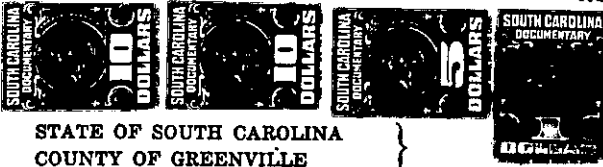

William A. Lynch, Jr. has been duly appointed as Substituted Trustee under the will of Ruth H. Lynch as will appear according to Decree of Honorable Frank Eppes, Judge of Thirteenth Judicial Circuit, said Decree having been recorded in Judgment Roll K-7527 in the Office of the Clerk of Court for Greenville County. William A. Lynch, Jr., Jacqueline L. Walters and Sonja L. Jones who are the sole beneficiaries under the will of Ruth H. Lynch are signing this deed to evidence their consent to this conveyance. This property is conveyed subject to all easements, restrictions, conditions and rights-of-way, if any, affecting said property.
