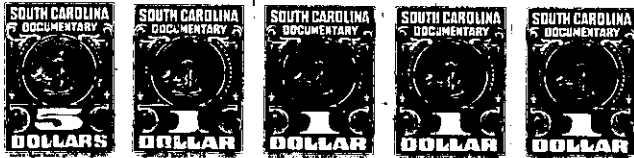

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near and East of the City of Greenville, and being known and designated as Lot Number 8 of a subdivision known as Terra Pines Estates Section 4, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book 000 at Page 85, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Compton Drive at the joint front corner of Lots 7 and 8 and running thence with the Southeastern side of Compton Drive N 19-30 E 65.2 feet to a point; thence continuing with the Southeastern side of Compton Drive N 22-09 E 88.3 feet to a point; thence still continuing with the Southeastern side of Compton Drive N 27-16 E 84 feet to a point at the joint front corner of Lots 8 and 9; thence S 59-54 E approximately 198.9 feet to a point in Gilbert Branch at the joint rear corner of Lots 8 and 9; thence with Gilbert Branch as a line approximately S 24-31 W approximately 124.6 feet to a point in Gilbert Branch; thence S 19-30 W approximately 76 feet to a point at the joint rear corner of Lots 7 and 8; thence N 70-30 W 200 feet to a point on the Southeastern side of Compton Drive at the point of **BEGINNING**.
