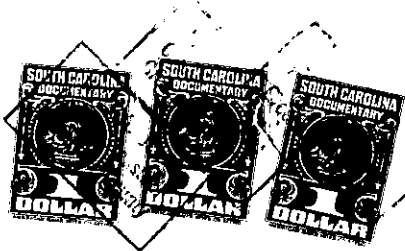
KNOW ALL MEN BY THESE PRESENTS, that I, Stanley I. Coleman, of Greenville County,

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 118 of a subdivision known as Coleman Heights according to a plat thereof prepared by Terry T. Dill, Surveyor, dated February, 1958 and recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 115, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Coleman Drive, joint front corner of Lots Nos. 118 and 119, and running thence with the joint line of said lots, S. 03-0 W. 166.8 feet to an iron pin at the joint corner of Lots Nos. 122 and 123; running thence with the line of Lot No. 123, S. 78-31 W. 142.3 feet to an iron pin at the joint rear corner of Lots Nos. 118 and 117; thence with the joint line of said lots, N. 05-48 W. 180 feet to an iron pin on the southern side of Coleman Drive; joint front corner of Lots Nos. 117 and 118; and running thence with the southern side of Coleman Drive, N. 81-12 E. 75 feet to an iron pin; thence continuing with the southern side of Coleman Drive, N. 87-07 E. 75 feet to the point of beginning.
