ALL that piece, parcel or lot of land situate, lying and being in Chick Springs Township, County of Greenville, State of South Carolina, shown as Lot #6 on Plat of Property of John W. Peden, prepared by Robert Jordan, RLS, dated November 21, 1967, consisting of 1.16 acres and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the edge of Crystal Lane at the joint front intersection of Lots Nos. 6 and 7 running thence N. 25-09 W. 384.7 feet to an iron pin; thence turning and running N. 68-08 E. 132.2 feet to an iron pin; thence turning and running S. 25-09 E. 377.1 feet to an iron pin at the edge of Crystal Lane; thence turning and running along the edge of Crystal Lane S. 64-51 W. 132 feet to the point of beginning.

The property conveyed herein shall be used only for a single family residence having 1200 or more square feet of heated living space.
