ALL that piece, parcel or lot of land with improvements thereon situate, lying and being in Greenville Township, Greenville County, State of South Carolina, being known and designated as a part of Riverside and being a portion of Lots 2 and 3 of Block DD as shown on plat of Riverside made by Carter & Pringle, and recorded in the RMC Office for Greenville County in Plat Book A; at page 232 and having, according to a more recent survey by C.
