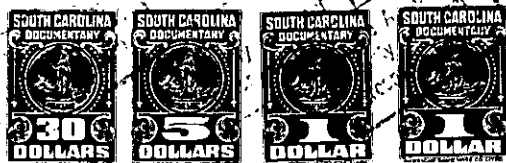
KNOW ALL MEN BY THESE PRESENTS, that I, Donald E. Baltz
