the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JOHN A. CURETON, HIS HEIRS AND ASSIGNS FOREVER:

All those pieces, parcels or lots of land in the City of Greenville, County of Greenville, South Carolina, Christ Church Cemetery, and being known and designated as two (2) grave spaces in Lots 3 and 6 of Section 49, the same described and designated in accordance with a plat of same recorded in Plat Book H, Page 300, in the R. M. C. Office for Greenville County. It is the intent of this deed to convey these two grave spaces to the grantee and the total square footage conveyed in this deed is 48 sq. ft.

It is distinctly understood that said lot is to be used exclusively for the burial of human bodies and is sold and conveyed subject to all rules and regulations printed on the back of deed from Christ Church Cemetery, a corporation, to Estate of J. A. Cureton, and any additions or amendments for the government of the Cemetery which may hereafter be adopted.

This is a portion of the property conveyed to the grantor by deed recorded in Deed Book 916, Page 498, in the R. M. C. Office for Greenville County.
