All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Hunting Hollow Road, near the City of Greenville, S. C., being known and designated as Lot No. 107 on plat of Foxcroft, Section I as recorded in the RMC Office for Greenville County, S.
