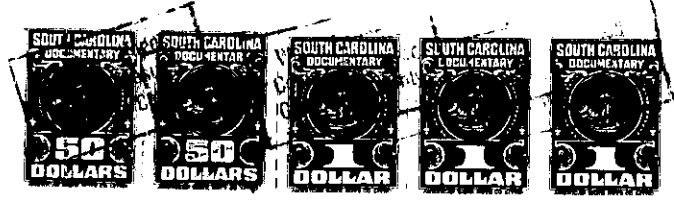

C., in Plat Book 4F, pages 2, 3 and 4 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Hunting Hollow Road, said pin being the joint front corner of Lots 107 and 108 and running thence with the common line of said lots S 10-09 E 165 feet to an iron pin, joint rear corner of Lots 107 and 108; thence N 79-51 E 131.9 feet to an iron pin, the joint rear corner of Lots 106 and 107; thence with the common line of said lots N 18-32 E 150 feet to an iron pin on the southerly side of Hunting Hollow Road; thence with the southerly side of Hunting Hollow Road N 76-04 W 40 feet to an iron pin; thence N 85-09 W 50 feet to and iron pin; thence S 84-51 W 50 feet to an iron pin; thence S 79-51 W 68.9 feet to an iron pin, the point of beginning.
