RONALD D. and CAMILLE S. PLEMMONS, their heirs and assigns forever:

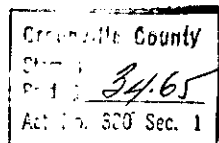
All that certain piece, parcel or lot of land being known and designated
