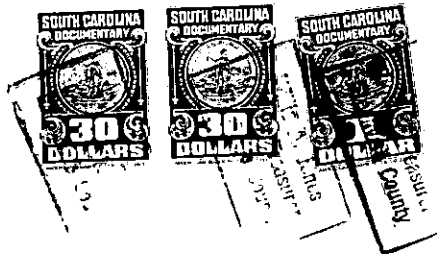
KNOW ALL MEN BY THESE PRESENTS, that JIM WILLIAMS, INC.
