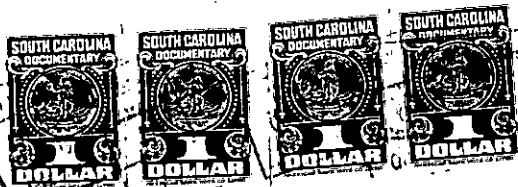
KNOW ALL MEN BY THESE PRESENTS, that HARRY B. CORRELL
