in consideration of Six Thousand Two Hundred Fifty and No/100 (\$6,250.00) -----Dollars,

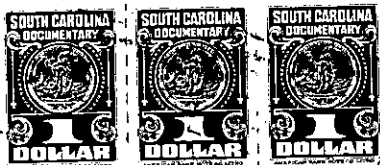
