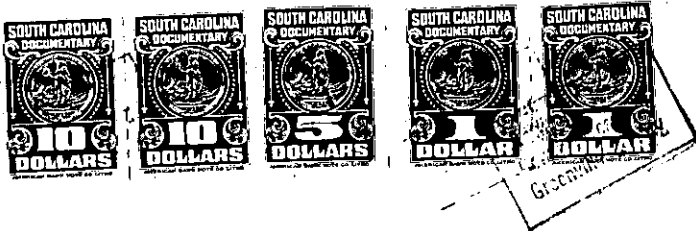
KNOW ALL MEN BY THESE PRESENTS, that M. H. Thompson, Jr. and Betty Thompson -----
