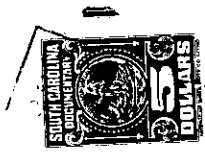
Know All Men by These Presents:

ALL of my right, title, interest and estate, the same being an undivided two-ninths (2/9) in and to all those pieces, parcels, or lots of land known and designated as Lots Nos. 32 and 35, of Schwiers Garden and having, according to a plat made by Piedmont Engineering Service, dated March, 1960, revised July, 1969, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Cleveland Street at the joint front corner of Lot No. 35 and property now or formerly of William Schwiers and running thence with the Western side of Cleveland Street S. 29-02 E. to a point; thence continuing with the Western side of said Street S. 27-27 E. to an iron pin at the joint corner of Lots 34 and 35; thence with the joint line of said Lot S. 55-34 W. 172.8 feet to the rear corner of Lots 34 and 35 and in the line of Lot 32; thence with the joint line of Lots 32 and 34 S. 29-55 E. 157.5 feet to an iron pin on the Northern side of Landsdown Avenue; thence with the Northern side of said Avenue S. 59-26 W. 120 feet; thence N. 37-33 W. 256.1 feet to an iron pin in the line of property now or formerly William Schwiers and Lot 32; thence with the joint line of Lots 32 and 35 with the property now or formerly of William Schwiers N. 46-45 E. 340 feet to an iron pin on the Western side of Cleveland Street, the point of beginning.
