KNOW ALL MEN BY THESE PRESENTS, that I, W. H. McCrary,

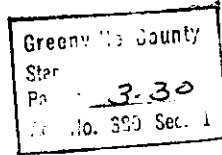
in consideration of --Three Thousand and No/100--(\$3,000.00)----- Dollars,
