All of those two certain pieces, parcels or lots of land situate, lying and being on the White Horse Road, in Bates Township, Greenville County, South Carolina, having the following metes and bounds, to wit:

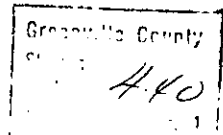
LOT BEGINNING on the White Horse Road at the joint corner of Lots Nos. 1 and 2 as shown on plat of survey made by W. A. Hester, October 18, 1947, and running thence S. 85½ E. 175 feet to an iron pin; thence S. 23½ E. 172 feet to corner of Lots No. 3; thence N. 85½ W. 249 feet to an iron pin on the White Horse Road; thence with said road N. 04½ E. 150 feet to the beginning corner, and being shown as Lot No. 2 on the plat aforesaid;

AND, ALSO,

LOT BEGINNING at an iron pin on the White Horse Road, corner of lot No. 2, and running thence S. 85½ E. 178 feet to an iron pin on Frank Bates line; thence N. 23½ W. 296 feet to an iron pin in old road; thence S. 24½ W. 112 feet to bend in new road; thence S. 4½ W. 160 feet to the beginning corner, and containing .53 of an acre, more or less.

The two lots above described are the same that were conveyed to the grantors herein by title deed from C. R. Timmons under date of August 16, 1971, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 924 at page 584.
