All that piece, parcel or lot of land situate, lying and being in the Town of Taylors, Chick Springs Township, Greenville County, State of South Carolina, and being more particularly described according to a plat entitled, "Survey for P.A. and Mattie Bennett Estate, Taylors, South Carolina," made by Carolina Surveying Company, the same being designated as Lot No. 8, on plat above referred to, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of a proposed road, joint front corners of Lots Nos. 7 and 8, which point is 420.6 feet east of the intersection of the proposed road and a County Road, and running thence S. 1-40 E. 662.3 feet to a point in the center of Marrow Bone Creek; thence with the center of Marrow Bone Creek as the line N. 67-42 E. 31.8 feet to a point in the middle of Marrow Bone Creek; thence continuing with the said Marrow Bone Creek as the line S. 63-07 E. 63.3 feet to a point in the center of Marrow Bone Creek; thence N. 1-40 W. 620.3 feet to an iron pin on the south side of a proposed road; thence with the south side of said proposed road N. 56-00 W. 105 feet to an iron pin, joint front corners of Lots 7 and 8, the point of beginning, and containing 1.2 acres, more or less.

This deed is made subject to any restrictions, easements and rights-of-way that may appear of record and/or on the recorded plat and/or on the premises.
