in consideration of One (\$1.00) Dollar, Love and Affection Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
Louella B. Tennant, her heirs and assigns, forever; the following described property,
to-wit:

All that piece, parcel or lot of land situate, lying and being in the Town of Taylors, Chick Springs Township, Greenville County, State of South Carolina, and being more particularly described, according to a plat entitled "Survey for P. A. and Mattie Bennett Estate, Taylors, South Carolina", made by Carolina Surveying Company, the same being designated as Lot No. 6 on plat above referred to, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of a proposed road, which point is 210.6 feet southeast of the intersection of said proposed road and a County Road, which intersection is 570.2 feet north of the center of Marrow Bone Creek where the same passes under said County Road, and running thence with the southwestern side of said proposed road S. 56-00 E. 105 feet to an iron pin on the southwest side of said proposed road; thence S. 1-40 E. 645.9 feet to a point in the center of Marrow Bone Creek; thence with the center of Marrow Bone Creek as the line, N. 83-10 W. 37.7 feet to a point in the center of Marrow Bone Creek; thence N. 21-11 W. 74.4 feet to a point in the center of Marrow Bone Creek; thence continuing with the center of Marrow Bone Creek N. 61-54 W. 26.6 feet to a point in the center of Marrow Bone Creek; thence N. 1-40 W. 618.5 feet to an iron pin on the southwest side of a proposed road, the point of beginning, and containing 1.3 acres, more or less.

This deed is made subject to any restrictions, easements and rights-of-way, that may appear of record and/or on the recorded plat and/or on the premises.

This is a portion of the same property conveyed to the Grantor by heirs of Mattie Bennett by deed being recorded simultaneous herewith in Deed Book 932, at page 365.
