POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That I, Jesse L. Cunningham, of the State and County aforesaid, do hereby constitute, make and appoint the Bank of Greer, Greer, South Carolina, as my true and lawful Attorney-in-Fact, for me and in my name to perform the following acts and deeds:

To receive for me and on my behalf any and all property due to me or inherited by me from the estate of J. C. Cunningham, my father, and from the estate of Lillie B. Cunningham, my mother, and to any other property I may own or be entitled to in the State of South Carolina with full power and authority to exercise any and every necessary authority to control and manage same including the authority to collect any monies on accounts due to me and to receive for me and in my name any checks made payable to me, or for my benefit, and to endorse my name thereon for the purpose of cashing same or depositing same to my accounts or account in any banks or bank wherein I or they may transact my business; to invest and re-invest principal and earnings of monies, bonds, or any other assets, real and personal; and my said Attorney-in-Fact is to have full power and authority under this instrument by its signature or that of its authorized officers to issue checks against and withdraw against any deposits or savings accounts at such times and in such amounts as deemed best for my welfare and benefit.

My Attorney-in-Fact is further empowered and authorized to execute any and all necessary instruments to carry on my business affairs including the execution of deeds, mortgages, notes and to compromise and settle any claims of notes and mortgages that I may owe; and to rent real property and collect rents due therefrom.

This Power of Attorney is applicable to property owned by me and in my name or to which I may be entitled in the State of South Carolina only and said Power is to continue until revoked by me in writing.
