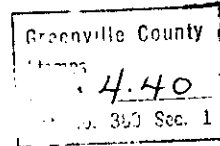
An undivided two-thirds (2/3) interest in and to all that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Meadow Lane near the City of Greenville, S.
